## **H&R Block Apologizes For Snafu**

H&R Block CEO Bill Cobb apologized to customers Friday night for a mistake that delayed refunds for



hundreds of thousands of customers. In an attempt to get customers' returns processed as soon as possible, given the late start to the filing season, the company "missed a step" Cobb concedes in a letter posted on H&R Block's Facebook page and a corporate blog. "I want you to know that we hear the frustration of those impacted by this issue loud and clear, and we're working every avenue we can to get your refund to you as fast as possible," he said.

As MarketWatch reported Tuesday, the IRS says that a the error was caused by a software glitch that failed to fill in a mandatory

field on Form 8863, which is used for claiming educational credits. In all, the error is delaying roughly 660,000 refunds by up to six weeks, according to the IRS, which declined to say how many of improperly field returns came from H&R Block. But the nation's largest tax preparer owned up to the mistake. While previously it was acceptable to leave certain boxes blank on the form to register a "no" response, the IRS now requests an "N," a change H&R Block did not make for returns processed before February 22. Over the past week and a half, thousands of complaints about the delays were posted to H&R Block's Facebook page and through Twitter. Taxpayers who had their returns held up by the glitch say the refund delays are causing them to fall behind on bills and are complicating the procedure for applying for financial aid. Others my blame it on a perfect storm of events: A late launch to the filing season, which started Jan. 30 – eight days later than usual – due to last-minute, "fiscal cliff" tax changes enacted by Congress; the inability of taxpayers to file for some credits until early March; and more diligent – but time-consuming – scrutiny of tax returns, part of the IRS' beefed-up efforts to thwart identity theft and tax refund fraud.

The average tax refund in 2012 was \$2,700, equaling more than a month's worth of income for two-thirds of taxpayers, or more than three months of groceries for the average family of four, according to the American tax and financial center at TurboTax, a competing provider of tax preparation software.

"Right now, our singular focus is to get you that refund, and we have all hands on deck to help make this right," Cobb said. H&R Block did not respond to requests for comment.
