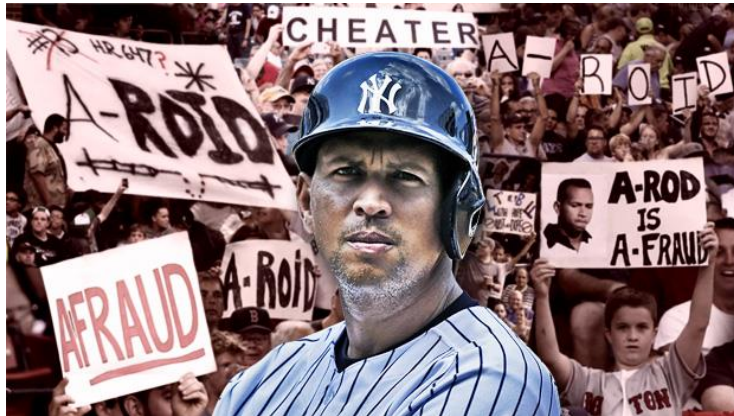


Alex Rodriguez Sues Major League Baseball

New York Yankees third baseman Alex Rodriguez filed a lawsuit against Major League Baseball on Friday alleging that the league has engaged in "tortious and egregious conduct" in an attempt to destroy his reputation and career.



The suit comes amid arbitration hearings in which Rodriguez is challenging the 211-game suspension handed down by MLB in August for his alleged use of performance-enhancing drugs. In the suit, Rodriguez alleges that MLB and its commissioner, Bud Selig, have acted "with one, and only one, goal: to improperly marshal evidence" against him using powers outside the collective bargaining agreement between the league and the players' union. The suit goes on to allege that Rodriguez

is being singled out "to gloss over Commissioner Selig's past inaction and tacit approval" of PED use and "to secure his legacy as the 'savior' of America's pastime." In a statement, MLB called the lawsuit "nothing more than a desperate attempt to circumvent the Collective Bargaining Agreement."

The league said: "While we vehemently deny the allegations in the complaint, none of those allegations is relevant to the real issue: whether Mr. Rodriguez violated the Joint Drug Prevention and Treatment Program by using and possessing numerous forms of prohibited performance-enhancing substances, including Testosterone and human Growth Hormone, over the course of multiple years and whether he violated the Basic Agreement by attempting to cover-up his violations of the Program by engaging in a course of conduct intended to obstruct and frustrate the Office of the Commissioner's investigation." The lawsuit is separate from Rodriguez's appeal, for which hearings began at MLB headquarters in New York on Monday and continued throughout the week. Once those hearings conclude, an independent arbitrator will decide whether to uphold, reduce or throw out the suspension. Rodriguez has declined to confirm or deny MLB's allegations.

The complaint, which was filed in State Supreme Court in Manhattan, makes a broad range of accusations related to MLB's tactics in its months-long investigation of Rodriguez, calling it "vigilante justice." It seeks "compensatory and punitive damages" from MLB. A key witness for MLB in the arbitration hearings is Anthony Bosch, who operated Biogenesis, the now-defunct Florida anti-aging clinic that allegedly distributed banned drugs to athletes. Twelve other players linked to the clinic, including Milwaukee Brewers slugger Ryan Braun, the 2011 National League MVP, accepted suspensions of shorter lengths. Bosch has not commented publicly on the allegations.

In the complaint, Rodriguez alleges that MLB is paying Bosch \$5 million "in order to buy his cooperation." Bosch's spokeswoman, Joyce Fitzpatrick, denied that claim Friday, saying, "He has not been paid nor will he be paid by MLB for his testimony. "The lawsuit also alleges MLB investigators purchased stolen documents related to the case from one of Bosch's former associates for \$150,000 in cash, "which was handed off in a bag at a Fort Lauderdale, Florida area restaurant."

According to Rodriguez's camp, they have also filed suit in State Supreme Court against Yankees team doctor Christopher Ahmad and New York Presbyterian Hospital/Columbia University Medical Center, alleging that Ahmad misdiagnosed Rodriguez's hip injury in the fall of 2012. At the time, Rodriguez complained of weakness in his hips. According to the Yankees he was examined by Ahmad, who first looked at Rodriguez's right hip, which had been surgically repaired in 2009, and found no problems in the repaired area. The suit alleges that at the time, Ahmad failed to inform Rodriguez about a new tear in his left hip, and the third baseman subsequently played in the 2012 playoffs.

The tear in his left hip required surgery this winter. Rodriguez missed the first half of the 2013 season. The hospital did not respond to a request for comment Friday night.

 - On March 8, 1930 – Babe Ruth signed a two-year contract valued at \$160,000. In an effort to assure posterity, Yankees General Manager Ed Barrow said, "No one in baseball will ever be paid more than Ruth." Alex Rodriguez earned \$32 million in 2009 as part of a ten-year \$275 million deal. Proportionately, how much more did Rodriguez earn annually than Ruth? **(MA.912.A.10.1; MA.912.A.5.4; MA.912.A.2.13; MA.912.A.5.1)**
 - Peter Edward Rose was actively employed in Major League Baseball as a player from 1963 – 1986 and a manager from 1984 – 1989. He is the all-time leader in hits yet he was suspended indefinitely from baseball for gambling which commissioner Bud Selig has since upheld. During his prime in the seventies, he was a member of an elite squad known as The Big Red Machine. During a routine practice drill, Johnny Bench was strategically positioned 60 ft to the east while Joe Morgan was 180 ft southeast. Meanwhile, 300 ft to the north, Tony Perez was 180 ft to the west and Pete Rose was 60 ft to the northwest. The angle formed between the paths of Bench and Morgan is congruent to the angle formed by the paths of Perez and Rose. If Bench and Morgan are now 156 ft apart, how far apart are Perez and Rose? Illustrate the diagram. Classify the triangle formed by its sides, measure the angles formed, and classify the triangle by its angles.
